## **Key experience**

Gilston Area Garden Town, East Hertfordshire (Places for **People)** – Rachel project manages a large team of consultants in this proposed new garden town of 10,000 homes to the north of Harlow. The project has involved working with the Local Planning Authority to secure the allocation of the land (previously Green Belt) for housing-led development, including the preparation of a Concept Framework, to demonstrate its deliverability. Rachel has prepared an outline planning application for the new town which will be developed as six distinct, sustainable villages surrounded by extensive parkland. Issues on the project involve determining an approach to application parameters which provides an appropriate balance between flexibility and certainty; setting an implementation and phasing strategy, including infrastructure triggers; determining an appropriate residential mix; responding to extensive heritage and environmental assets and integrating with a large and complex Environmental Impact Assessment process. planing permission for, and now implementing, two strategic crossings of the Stort Valley, including five new vehicular bridges; and preparation of a Strategic Landscape Masterplan and the first Village Masterplan to develop the outline proposals.

Bacton Low Rise Estate Regeneration, Camden (London Borough of Camden and EC Harris) – Rachel coordinated the development of a redevelopment strategy and subsequent full planning application for this estate regeneration project of 300 residential units, employment units, new open space and public realm in the Gospel Oak area of Camden. Key issues on the project included defining an appropriate tenure mix for the proposed scheme; agreeing proposals for the loss of existing employment units and achieving a design solution which was economically viable, whilst respecting the character of a Grade I listed church located directly adjacent to the site. The project involved extensive public and stakeholder consultation to develop and refine the proposals. The scheme is currently being implemented.

Brent Cross Cricklewood Town Centre and Regeneration Area, Barnet (Hammerson and Standard Life) – Rachel was involved in implementing the section 73 consent for this new metropolitan town centre, including 7,500 new residential properties, circa 100,000m2 retail floorspace, 395,000m2 office floorspace, involving submission of reserved application matters, discharging planning conditions, reviewing the extensive section 106 agreement and compliance matters.

Hinkley Point C Nuclear Power Station Development Consent Order, Somerset (EDF Energy) – Hinkley Point C comprises a 67 hectare main site and eight associated development sites, including a refurbished wharf and new bypass. Rachel's responsibilities included writing the overarching strategic Design and Access Statement for the project; carrying out the Alternative Sites Assessment to support the compulsory acquisition of land and writing the Legacy Strategy for the project. Rachel also provided planning support to the inquiry for a harbour empowerment order to authorise the creation of a harbour and temporary jetty at the site.

**Heathrow Airport (Heathrow Airport Limited)** – Rachel provided planning inputs related to rationalising and expanding airport operations at Heathrow Airport.
