**Mansfield Street, York** – Emma helped secure planning consent for the second phase of purpose-built student accommodation on behalf of Urbanite. She led the co-ordination of the project team, prepared and submitted the application, led on the negotiation of the planning and has since negotiated minor amendments to the scheme.
