Botley Road Oxford – Hannah is providing planning support on the delivery of a new state-of-the-art research and development facility on Oxford, on behalf of Columbia Threadneedle Investments.

Valor Park Greenford – Hannah worked with Valor to deliver a new industrial building comprising 3no. units adjacent to the Paddington Branch canal within the Greenford Industrial Estate, Ealing. The scheme comprised 13,167sqm of flexible B2/B8 floorspace with associated yard, parking and landscaping, delivering c.277 FTE job opportunities. Hannah liaised with the consultant team to address any concerns raised by the Council and key consultees, including the Canal and River Trust, to allow the delivery of a 24/7 operation industrial scheme. The scheme received unanimous resolution to grant at Planning Committee.

Valor Park Tottenham – Hannah worked with Valor to deliver 2no. new industrial units in the Hotspur Industrial Estate comprising 6,312sqm of flexible B2/B8 floorspace. The exemplar industrial development includes ancillary mezzanine floorspace and associated landscaping, yard, parking, access and infrastructure, delivering 133 FTE job opportunities for local people. Hannah liaised with the consultant team to address and resolve any concerns raised by the Council and Quality Review Panel, including the impact of the scheme on the adjacent residents and allowing the 24/7 operation of the units. The scheme received unanimous resolution to grant at Planning Committee and the scheme has been praised as exemplary for the area.

Valor Park Thames Road – Hannah is currently working with Valor to deliver a new industrial unit in Barking. The scheme comprises 8,048sqm of flexible B2/B8 floorspace, delivering c. 170 FTE job opportunities within the Thames Road industrial area.

Heathrow Flightpath EV Car Park – Hannah is currently working with Lysara to deliver an EV charging fleet hub with associated retail uses near Heathrow.
