UK Industrial Fusion Solutions (UKIFS) Fusion Energy – Spherical Tokamak for Energy Production (STEP) – Tom provides ongoing support for the UK's first fusion power station's DCO. This includes preparation of consultation material for non-statutory consultation; as an emerging technology and demonstrator project, consultation material was focused jointly on garnering support for the development while maintaining a grounded sense of commercial and technological viability.

Dalradian Gold Inc. – Curraghinalt Project (Gold Mine) – Tom provides ongoing support on the Curraghinalt Project, a gold mine in Northern Ireland. Tom authored a bespoke socioeconomic assessment of the area the mine resides in and a bespoke, data-led estimation of its economic impacts. His work included preparing public inquiry material in response to public consultation and assessing transboundary effects.
